# **Committee Reports**

**Financial:** Our financial results are a little weak. The month of July showed a loss of \$(9,000) and YTD our loss is \$(26,000). At \$142,000 our cash balance is still substantial but is the lowest it has been in a year. We will continue to monitor this closely.

### **Other Business**

**Sexual Harassment Policy**: The policy has been reviewed through a DEI lens and the Ethics Committee made comments and suggested changes. Tsuho has what is (hopefully) the final edit that he will circulate for approval by the board.

**Cash Management:** Sam suggested that Jyoshin close the savings account at OnPoint Bank and open an online savings account at Ally Bank. This will improve the return on savings from virtually nothing to 4.25%. The money will be FDIC insured and easily transferrable in and out of our checking account. It will require some closer attention to checking balances.

**Development Proposal:** Kakumyo has been developing plans and pro-forma financial projections for the construction of a self-funded smaller building which would include a classroom to expand Frog Song and for Dharma Garden. It would potentially also include additional upstairs living space. The concept was explained and discussed at a high level.

# **Upcoming Events**

Fall Sangha Forum October 15. The October board meeting was moved up to October 12 for some extra time to prepare.

Emerging Sangha Leadership Training is March 2024. Hoping to provide intensive training for 15-20 upcoming Sangha leaders from around the country.

**Alice** – Get an update of fundraising for the solar project from Zachary and circulate to the board. We did not have up to date numbers for the meeting.

**All** – think about 2 or 3 topics for the Fall Forum. Kakumyo is looking for a volunteer to help write the end of year fundraising letter.
